

# **SINGLE USER LICENCE FOR UNITED KINGDOM CYSTIC FIBROSIS SOFTWARE SYSTEM**

This is a Licence under which the University of Dundee (the "Licensor") agrees to supply the U.K. Cystic Fibrosis Software System (the "Software") and associated Guide and Installation Instructions (the "Documentation") to:

(the "Licensee") on the following terms and conditions.

The Licensee agrees to accept the Software and Documentation on the terms and conditions indicated below.

**1** The Licensor, on receipt of the signed copy of this licence, agrees to provide the Licensee with the Software and Documentation as described above.

**2 PURPOSE OF LICENCE**

The copyright and any other Intellectual Property Rights in the Software and Documentation is held by the Licensor subject to any moral rights of the individual authors of the Software. Unauthorised copying of the Software and/or Documentation, is copyright infringement and is a criminal offence.

**3 GRANT OF LICENCE**

The Licensor hereby grants a non-exclusive Licence to the Licensee to use the Software and Documentation as described below :

- to be installed on one machine only,
- to be used unmodified for internal, non-commercial purposes.

**4 RESTRICTIONS & OBLIGATIONS**

The Licence shall not extend to permit the Licensee to, nor extend to allow the Licensee to permit others to :

- Copy, reverse engineer, decompile or disassemble, the Software in any way (Save as permitted by article 6 of the Directive on the Legal Protection of Computer Programs 91/250/EEC).
- Modify, translate or adapt the Software or Documentation.
- Distribute, rent, loan, sub-licence, sell or otherwise transfer all or part of the Software, documentation or any rights granted hereunder to any other person without prior written consent from the Licensor.

The Licensee shall retain all manual data entry forms and the Licensor shall be entitled to request copies of any or all of them from time to time.

The Licensee shall forward to the Licensor on a quarterly basis an electronic transfer of the clinical data recorded in the immediately proceeding quarter.

**5. MAINTENANCE/SUPPORT/IMPROVEMENTS**

The Licensor shall be under no obligation to provide support of any nature for the Software and Documentation, unless specifically agreed with and authorised by UKCF Database Centre. In addition, the Licensor is under no obligation to update or otherwise amend the Software and Documentation or to make available any updated versions as may be developed.

**6 WARRANTIES AND INDEMNITIES**

The Licensor does not give any representation, warranty or undertaking as to the effectiveness, quality or fitness for any purpose of the Software or the Documentation, or that the Software or the Documentation supplied by the Licensor is free from any defect or error.

The Licensor shall not be liable for any defect in the Software or Documentation or for any loss, damages or injury whatsoever or howsoever caused arising directly or indirectly out of the use of the Software or Documentation (except to the extent that such liability may not be lawfully excluded). The Licensee agrees to indemnify the Licensor a) in relation to any claim arising out of the use of the Software or Documentation in the Licensee institution and b) for any breach of this Licence.

The Licensee shall arrange for their own updates to the Anti virus software supplied after the first twelve months.

**7 TERMINATION**

**Duration**

- The Licence to use the Software and Documentation starts on receipt of the Software and Documentation from the Licensor, and shall continue until the Agreement is terminated in accordance with the provisions of this clause.
- The Licensee may terminate this licence upon giving not less than one month’s written notice to the Licensor.

**Grounds for Termination :**

- Unauthorised copying of the Software or Documentation or failure to comply with any term, condition or provision of this Licence Agreement will result in summary termination of the Agreement upon notice of the Licensor.

**After Termination**

- Any use of any copies of the Software or Documentation after termination of this Agreement is unlawful. Upon termination for any reason the Licensee must immediately cease all use of the Software and Documentation and destroy all copies.
- On termination, for breach of the Licence, the Licensee shall pay to the Licensor all and any costs and expenses, including legal and other fees incurred in respect of said breach.

**8** This Agreement shall be covered by the laws of Scotland and shall be subject to the jurisdiction of the Scottish Courts.
